# **Privacy Policy**

Vision Xperts Eye Hospital . ("hereafter referred as Vision Xperts Eye Hospital in this document/page") is concerned about the privacy of its users (hereinafter referred to as "You" "Your" "Yourself") accessing its website located at www.Vision Xpertseye.com ("Website") and has provided this Privacy Policy ("Policy") to familiarise You with the manner in which Vision Xperts Eye Hospital collects, uses and discloses Your information collected through the Website and/or Portal. BY USING THE WEBSITE, YOU AGREE AND CONSENT TO THE TERMS AND CONDITIONS OF THIS POLICY. IF YOU DO NOT AGREE WITH AND/OR CONSENT TO THE TERMS AND CONDITIONS OF THIS POLICY, PLEASE DO NOT PROCEED FURTHER TO USE THIS WEBSITE.

This Policy is an electronic record as per, and has been prepared keeping in mind Vision Xperts Eye Hospital compliance to the provisions of, the Information Technology Act, 2000 and the rules framed thereunder, as applicable to Vision Xperts Eye Hospital.

# **Information and Usage**

This Privacy Policy explains how Vision Xperts Eye Hospital collects personal and non-personal information, classified as mandatory or voluntary and uses, discloses and protects such information through the Website. 'Personal Information', "sensitive personal data and information or SPDI", "data", "information" shall all have meanings given to them under applicable law. Personal Information for the purposes of this Policy shall include, but not limited to, information regarding your name, address, telephone number, date of birth, gender, e-mail address, etc.

# Type of personal data and SPDI collected

You may need to voluntarily provide Vision Xperts Eye Hospital Your Personal Information/SPDI during the course of using some services of the Vision Xperts Eye Hospital. Such information may include but is not limited to:

 Creating a User ID by You which will require to provide your Name, Gender, Mobile Number, Email Id and Date of Birth, medical data if any required etc. or any other information/data required to conduct a particular piece of work/activity or data processing

- Providing information in Your account while registering on the Website like Name, Gender, Mobile Number, Email Id and Date of Birth, medical data if any required etc. or any other information/data required to conduct a particular piece of work/activity or data processing
- Providing financial information like credit card, debit card or other payment instrument details while making an online purchase.
- Uploading medical records and personal/family history like medical reports, prescriptions, surveys, questionnaires or any other information/data required to conduct a particular piece of work/activity or data processing and details of physical, physiological and mental health condition.
- Participating in any online survey or contest
- Communicating with Vision Xperts Eye Hospital customer service by phone, email or otherwise
- Providing reviews for the content available on the Website
- Providing other information/ data voluntarily provided to us by You.

Please note that any information that is freely available or accessible in public domain or furnished under any law for the time being in force shall not be regarded as SPDI.

### Purpose of collection and usage

Vision Xperts Eye Hospital collects only such Personal Information/ SPDI that Vision Xperts Eye Hospital believes to be relevant and is required to understand you or your interests and serve you better. Vision Xperts Eye Hospital collects Your Personal Information/ SPDI in order to record, support and facilitate Your participation in the activities You select, track Your preferences, to provide You with a customized Website experience, to notify You of any updated information and new activities and other related functions offered by Vision Xperts Eye Hospital, keep You informed about latest content available on the Website, special offers, and other products and services of Vision Xperts Eye Hospital, to assist You with customer service or technical support issues, to follow up with You after Your visit, to otherwise support Your relationship with Vision Xperts Eye Hospital and/or to prevent fraud and unlawful use.

In an effort to make our Website effective, certain information may be collected each time you visit the Website. Such information may be stored in server logs. These encrypted statistics do not identify You personally, but provide us the information regarding your visit to the Website and the type of user who is accessing our Website and certain browsing activities by You. This data may include: IP address of your server from where the Website is being accessed, the type of browser (Internet Explorer, Firefox, Opera, Google Chrome etc.), the operating system of Your system and the Website You last visited before visiting to our Website. The duration of your stay on our Website is also stored in the session along with the date and time of your access. These kinds of data are used by Vision Xperts Eye Hospital to understand the use and number of users visiting the Website. Some of the information related to the Website and Your visit to the Website may be shared by the sponsors, investors, advertisers, developer, strategic business partners of Vision Xperts Eye Hospital and some associates in order to enhance and grow our

business and the Website but we assure that this information will never include any of Your Personal Information/ SPDI. This anonymous information is collected through the use of a pixel tag, which is industry standard technology used by most major Websites. When you use the Website, Vision Xperts Eye Hospital servers (which may be hosted by a third party service provider) may collect information indirectly and automatically about Your activities on the Website; for instance, by way of cookies. A cookie is a small amount of data that is sent to a user's browser from a web server and is eventually stored on a user's computer hard drive. This anonymous information is maintained distinctly and is not linked to the Personal Information/ SPDI You submit to Vision Xperts Eye Hospital. Whether you want your web browser to accept cookies or not is up to you. If you haven't changed your computer's settings, most likely your browser already accepts cookies. If you choose to decline cookies, you may not be able to fully experience all features of the Website. They include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, platform type, date/time stamp, and number of clicks. We use them to analyse trends, administer the site, track a user's movement and gather broad demographic information for aggregate use. These are not linked to personally identifiable information/ Personal Information/ SPDI. Vision Xperts Eye Hospital DOES NOT trade or sell Your Personal Information/ SPDI in any manner, except as specified herein or if express consent is sought from you. Personal Information/SPDI provided by you is used only: (a) to facilitate Your use of the Website; (b) to respond to Your inquiries or fulfil Your requests for information about the various services; (c) to provide You with information about Vision Xperts Eye Hospital's products/services and to send You information, materials, and offers from Vision Xperts Eye Hospital; (d) to send You important information regarding the Website, changes to Vision Xperts Eye Hospital terms, conditions, and policies and/or other administrative information; (e) to send You surveys and marketing communications that Vision Xperts Eye Hospital believes may be of interest to You; (f) to send you appointment reminders, reports, reminders for your next check-up or any other relevant alerts/communications pertaining to you including and not limited to only check-ups/tests based on your medical data (g) to personalize Your experience on the Website and Vision Xperts Eye Hospital other websites by presenting advertising, products and offers tailored to You; (h) to help You address Your problems with the Website including addressing any technical problems; (i) if You purchase any content or avail of any service from the Website, to complete and fulfil Your purchase, for example, to have Your payments processed, communicate with You regarding Your purchase and provide You with related customer service; (i) for proper administering of the Website; (j) To conduct internal reviews and data analysis for the Website (e.g., to determine the number of visitors to specific pages within the Website); (k) to improve the services, content and advertising on the Website; (1) to protect the integrity of the Website; and (m) to respond to judicial process and provide

information to law enforcement agencies or in connection with an investigation on matters related to public safety, as permitted by law.

You acknowledge that apart from Your Personal Information/SPDI, if you upload any content on the Website, such content may contain information including Personal Information/SPDI and the same may be available to the other users of the Website. Vision Xperts Eye Hospital will not be liable for the disclosure and dissemination of such Personal Information/SPDI to third parties.

Vision Xperts Eye Hospital may disclose aggregated information about the use of the Website, but it will never contain Personal Information/SPDI. # **User Discretion**

You can always choose not to provide information and in such cases, if the information required is classified as mandatory, You will not be able to avail of that part of the services, features or content. You can add or update Your Personal Information/SPDI on a regular basis. When You update information, Vision Xperts Eye Hospital may keep a copy of the prior version for its records. You are responsible to ensure that correct data is uploaded and/or no overwriting of the records are done by replacing the name or any other medically relevant data point which has impact on medical data, your health trend charts etc. Vision Xperts Eye Hospital may, if You so

choose, send direct advertisement mailers to You at the address given by You. You have the option to opt-out of this direct mailer by clicking at the unsubscribed link option attached to e-mail.
